City of Byram, Mississippi Privilege License Schedule

Anyone who conducts business in the City of Byram must obtain a Privilege License (State Code 27-17-9), except for business that are specifically exempted by state or federal statute. Privilege License fees are required to be paid prior to the opening of a business are renewable on an annual basis, October 1 – September 30.

The amount of a privilege license is based upon the number of employees and type of business. Service businesses (including non-manufacturing and manufacturing) are calculated on the number of employees.
